

Title	Private Native Forestry Koala Prescription Map
Abstract	<p>The PNF Koala Prescription Map identifies areas that are mapped as high koala habitat suitability for the purpose of implementing the koala protections under the Private Native Forestry Codes of Practice. The dataset represents a predictive habitat model with inputs from a range of scales and accuracies.
