Lineage

This dataset is part of the extension of the vegetation mapping using CRA methodology in two areas west of the original CRA boundary to match the Riverina Highlands Regional Vegetation Management Area boundary. Developed for the Riverina Highlands Native Vegetation Region by the Regional Vegetation Management Committee under the Native Vegetation Conservation Act 1997.

The RHRVC has identified biolinks on ridgelines and riparian areas. Riparian vegetation is one the most cleared of all vegetation types within the region. Vegetation on ridgelines is often all that is left, due to the fact that the larger remnants are mostly on steep ridgelines unsuited to clearing for agriculture.
