These measures are summarised in an options assessment matrix which highlights quantifiable impacts, costs and benefits, but also intangible considerations such as social and environmental factors. The matrix can be used to compare options and inform the selection of measures to be adopted for implementation. Measures are also marked on Figure ES-1 in report where possible / appropriate. A number of other measures were considered during the study.
