Abstract	<p>These datasets represent management units within in-force water sharing plans across NSW, including regulated, unregulated and groundwater plans (or a combination of these). The data includes both water sources and management zones (where applicable) derived from plans gazetted under the NSW Water Management Act 2000. The boundaries of these water sources and management zones are used to define areas in which specific management rules apply. As such, this data may be used to understand which water sharing plan rules apply to a specific location. The plans are in place for 10 years but may be amended within this time.
